The Golden Buddha Centre project began in 1998 with the twin objectives of having a Buddhist centre together with associated residential accommodation for retired Buddhists.

Zeal Cottage (purchased in 2002) ran as a Buddhist centre offering events, personal study and practice, a library and peaceful meditation room. It was sold in November 2008 in order to free up some capital and to move the Golden Buddha project forward.

The next step is to find an alternative property to be the centre. This will be most likely in or near Totnes — an environment which would be suitable for retired Buddhists — with its housing of various kinds, rail and bus networks, and other services.

Once the centre is setup, properties will be sort nearby for those wishing to live a simple Buddhist lifestyle while at the same time retaining their privacy and independence (medical or living assistance cannot be given—which would need to be obtained in the usual way from local health and social services).
